



2008 LICENCE APPLICATION & MEMBERSHIP FORM

BikeNZ issues Race Licences for Mountain Bike, Road and Track and are valid for one calendar year.

A BikeNZ Race Licence allows you to compete in most mountain bike, road or track events run by an affiliated Club or Centre, or sanctioned by Mountain Bike NZ (MTBNZ), Cycling NZ (CNZ), or BikeNZ. Note: You may need a clearance from your club and in some instances, e.g. National Championships, you may also need to be a financial member of the Member Organisation holding the Championships. Ensure you check the licence requirements with the specific event.

You cannot use a BikeNZ licence to compete in BMX events. For details on licences for BMX, contact BMX NZ on admin@bmxnz.co.nz

YOUR MEMBER ORGANISATION

You must select either CNZ or MTBNZ as your Member Organisation. Completion of this form records your agreement to be a member of your chosen Member Organisation. This is the organisation with whom your licence is held, and you are bound by its constitution, rules and regulations. In most cases, your affiliated club will determine your Member Organisation. However there are a number of clubs that are affiliated to both CNZ and MTBNZ. If you have any queries regarding this, please talk with your club.

RACE LICENCE TYPES

There are 4 types of race licences available: Club (CNZ only), Centre (CNZ Only), National and International, and, as the names suggest, each licence allows you to race in the different levels of competition.

You must be a financial member of an affiliated club to be eligible for a racing licence. See www.bikenz.org.nz for details on affiliated clubs.

You are able to upgrade throughout the year by paying the difference in fees. Contact BikeNZ for further information.

INTERNATIONAL LICENCES

UCI requirements state that insurance must be included with the purchase of an International Licence. Ensure you complete the insurance section at the end of this application.

You must email a jpg photo of yourself, without a hat or sunglasses to office@bikenz.org.nz to appear on your licence before it can be processed. Ensure you include your full name with your photo.

TECHNICAL LICENCES

A Technical Licence caters for Commissaires, Managers, Mechanics and Soigneurs and allows licence holders to attend National and International Events in an official capacity. Event Promoters can also obtain a Technical Licence (\$150) which allows them to utilise Commissaires for their events.

LICENCE CATEGORIES

Your Licence Category states which category you compete in, and in most cases, is determined by your age. There are circumstances, however, which allow you to compete outside your normal category. Contact your club for further details.

Where you use your licence with another Member Organisation, your category may vary according to the category structure.

CNZ Members

Please submit this application and all relevant fees (including Club and Centre Fees) to your Club. Do not post to BikeNZ unless you are applying for either a Technical Licence and do not intend to compete, or for an International Licence Upgrade.

MTBNZ Members

Submit your application direct to BikeNZ with payment.

If additional insurance is required after the issue of the original International Licence, application should be made directly to the BikeNZ office, advising the new period of cover required, including the appropriate additional insurance portion for the new period.

Insurance cover will only apply during the dates specified in your application. It will be your responsibility to advise BikeNZ of any extensions to the dates specified in the application.

Insurance cover will include the following:

Both options cover the following

- Full terrorism cover
- The excess for all claims excluding training and competition will be \$250.
- The excess for any claim for an incident whilst training or in competition will be \$500.
- Personal Effects up to a maximum of \$20,000 per person, with a limit \$5000 any one item.

Bike & Bike Equipment Insurance Extension

- Cover for damage to bikes (including bike accessories e.g. wheels) whilst in transit only applies if the bike and/or accessories are properly and securely packaged in a suitable hard case; the only other time cover applies is when the bike and its accessories are properly secured in a locked premises.
- Bike equipment and accessories have a limit of \$15,000; any item over that will need to be specified.
- The excess for all equipment claims will be \$1000, unless the insured item is over \$10,000, in which case the excess will be 10%.
- Any damage to bike equipment whilst racing or training is **not** covered – even when separately insured.

DECLARATION

I, the person who has applied to BikeNZ and either CNZ or MTBNZ (my Member Organisation) for a Licence and to become a member of my Member Organisation:

1. Declare that:

- (a) I am not aware of any reason why I should not be issued with the licence requested;
- (b) I have not applied for a licence for the same year to the International Cycling Union (UCI) or to any other national cycling federation;
- (c) I assume exclusive liability for this application and for the use I will make of the licence.

2. Undertake to:

- (a) return my licence immediately in the event of any substantial change to the circumstances existing at the time of this application;
- (b) comply with the constitutions, regulations, policies, manuals, guidelines and reasonable directions of BikeNZ, my Member Organisation and the UCI ;
- (c) participate in cycling competitions and events in a fair and sporting manner;
- (d) submit to disciplinary measures taken against me by BikeNZ, my Member Organisation or the UCI and take any appeals and litigation before the authorities provided for in the Constitution or Regulations of BikeNZ, my Member Organisation or the UCI;
- (e) accept the Judicial Panels established by BikeNZ and my Member Organisation , the New Zealand Sports Disputes Tribunal and the Court of Arbitration for Sport (CAS) as the only competent jurisdictions in cases provided for by the Regulations of BikeNZ, my and UCI and that, in the case of CAS, its decisions will be final and binding and not subject to further appeal;
- (f) subject to paragraph (e), submit any litigation with the UCI exclusively to the tribunals at UCI headquarters.

3. Undertake to comply with the Anti-Doping Policies of BikeNZ and my Member Organisation , the UCI Anti-Doping Regulations, the clauses of the World Anti-Doping Code and its International Standards to which the UCI Anti-Doping Regulations refer, as well as the anti-doping regulations of other competent bodies as per the UCI Anti-Doping Regulations and the World Anti-Doping Code, provided that those regulations comply with the World Anti-Doping Code. I accordingly acknowledge and accept:

- (a) that all urine samples taken will become the property of the UCI, which may have them analysed, especially for purposes of health protection research and information;
- (b) that the results of any analysis may be made public and communicated in detail to my club or team or to my paramedical assistant or doctor;
- (c) that my doctor or the doctor of my club or team may, on request from the UCI, communicate to the UCI a list of any medicines I took and treatment I underwent before any given competition;
- (d) the conditions regarding blood testing and agree to undergo blood tests.

4. The details set out in the Application for a Licence and Membership Form are true and correct. If they change I acknowledge that I am required to notify BikeNZ of the changes, in writing, as soon as possible after they occur.

5. I understand and agree that BikeNZ and my Member Organisation will collect, hold, use and disclose personal information about me for the purposes of:

- (a) enabling BikeNZ and my Member Organisation to have a register of their members as required by section 22 of the Incorporated Societies Act 1908;
- (b) determining the exact number and categories of the members of my Member Organisation and BikeNZ;
- (c) determining the membership fee payable by my Member Organisation to BikeNZ;
- (d) determining the interests and nature of the membership at local, district and national level for the purposes of determining which sponsor and/or stakeholders may be appropriate for my Member Organisation and BikeNZ;
- (e) enabling my Member Organisation and BikeNZ to communicate with me and other members about my membership and matters affecting my Member Organisation and BikeNZ such as their events, activities, seminars including communicating with you through newsletters, emails, texts and other electronic messaging and for this purpose to supply the information to mail houses;
- (f) having and maintaining a national database for use by employees and officials of my Member Organisation and BikeNZ, and for use by other members of my Member Organisation and BikeNZ, and in order to maintain this database to enable my Member Organisation to pass the information onto BikeNZ;
- (g) enabling my Member Organisation and BikeNZ to provide my details to sponsors and stakeholders for the purposes of sponsors or stakeholders contacting members with information about their products and services;
- (h) enabling my Member Organisation and BikeNZ to provide my details to UCI for the purposes of maintaining my licence and membership of my Member Organisation and BikeNZ;
- (i) enabling my Member Organisation and BikeNZ to comply with any statute, regulation, by-law or other regulatory instrument that requires collection or disclosure of my personal information;
- (j) any other purpose I agree to in writing.

6. I understand that my personal information will only be used for the purposes listed in paragraph 5 and that my personal information will be held securely, I will have access to my personal information; and my personal information will be corrected upon request.
